Bids are invited by Indira Gandhi National Open University (IGNOU) for disposal of Scrap Material (e-waste/ furniture/general equipment/electrical Items /misc Items etc.) as per Annexure I & II from its office located at IGNOU Regional Center 70/79-84, Sector-7, Patel Marg, Mansarovar, Jaipur- 302020 "AS IS WHERE IS BASIS".

- 1. The technical and financial bid are to be submitted separately.
- The valid copy of authorized recycler certificate, copy of ID proof, (Self attested copy of Voter ID /Aadhar Card and PAN card etc.), and Demand Draft are to be submitted in the technical bid.
- The amount should be mentioned in the financial bid format. The highest bidder will be declared based on the total amount quoted in the financial bid format.
- The financial bid of only the technically qualified bids would be opened.
- 5. For disposal of e-waste scrap, only authorized Dismantler, Recycler, Registered PRO, EPR-authorized producers are only allowed to participate in the tendering process under E-waste Rules. The lists of E-waste may be seen at Annexure –I. The lists of furniture/ lab equipment/electricals/miso items etc. scraps materials may be seen at Annexure II.
- The materials offered for disposal is on "AS IS WHERE IS BASIS" in Premises of IGNOU Regional Center Jaipur in unpacked condition.
- 7. The bidders may inspect the materials on any working day between 9.30 AM to 6.00 PM. No complaint whatever will be entertained after the tenders are submitted or before or after the materials are lifted. No request for samples or inspection after submission of the tender will be accepted.
- Closing date & time for receipt of tender (scraps): on 11.01.2022 at 11:00 A.M.
 Opening date & time of tender (scraps): on 12.01.2022 at 11.00 A.M.

- 9. All bidders/tenderers should submit their tender /bid along with a Demand Draft of Rs. 10,000/- (Rupees Ten Thousand Only) in favour of IGNOU RC Jaipur as Earnest Money Deposit (EMD) which will be refundable to unsuccessful bidders. The EMD of the successful bidder shall be retained and will be returned after submitting the Demand Draft of full amount as quoted in the bid. Tender should be supported with proof of identity (self-attested copies of Voter ID/Adhar card and PAN card etc.)
- 10. No tenders shall be accepted/entertained without earnest money deposit.
- 11. Only the highest bidder will be considered subject to the final decision of Competent Authority, IGNOU RC Jaipur.

- 12. The highest bidder has to deposit the bid amount in form of Demand Draft payable to IGNOU RC Jaipur within three working days, from the date of receipt of the Award of Work. The materials have to be removed within 5 days from the date of receipt of award letter/gate pass for removal of the material from IGNOU RC Jaipur.
- The person authorized by the highest bidder will only be allowed to take out the scrap materials from IGNOU RC Jaipur.
- 14. The Local Purchase Committee (LPC) reserve the right to withdraw any material from the sale of any material's lots at any stage without assigning any reasons thereof.
- 15. Since, the disposal of the material is on "AS IS WHERE IS BASIS" basis, the removal process should be in a very peaceful and smooth manner. No one shall be allowed to play any objectionable acts while removing the material from the premises of IGNOU RC Jaipur.
- 16. The highest bidder has to submit the amount within three days from the date of receipt of Award letter and if he fails, the earnest money will be forfeited.
- In case of any dispute, the decision of the Chairperson, IGNOU RC Jaipur shall be final and binding on both the parties.
